20. ITEMS RECOMMENDED FOR CONSIDERATION IN CONFIDENCE:

20.2 Council Dredging Operations

Pursuant to section 90(2) of the Local Government Act 1999 the Council orders that all members of the public, except the Chief Executive Officer, Director Infrastructure & Operations, Director Corporate Services, Finance Manager, Sustainability & Projects Coordinator, Dean Newbery Consulting and the Minute Taker, be excluded from attendance at the meeting for agenda item 20.2 "Council Dredging Operations".

The order is made on the ground that, pursuant to Section 90(3)(b)(i) of the act, the information to be received, discussed or considered in relation to this agenda item is information the disclosure of which would involve the unreasonable disclosure of information concerning the commercial nature of the report, which could reasonably be expected to prejudice the commercial position of the Council.
